Western End Sanitary Sewer Extension Project


Dear Resident,

The Authority is recommending to the Northampton Township Board of Supervisors the exploration of feasibility to amend the scope of the Western End Sanitary Sewer Extension Project. We are requesting consideration being given to eliminating certain outlying areas from the project at this time by amending the Township's current 537 Plan. These areas were identified as regions that have not had a history of failed systems and are grouped making them logical for possible project amendment.

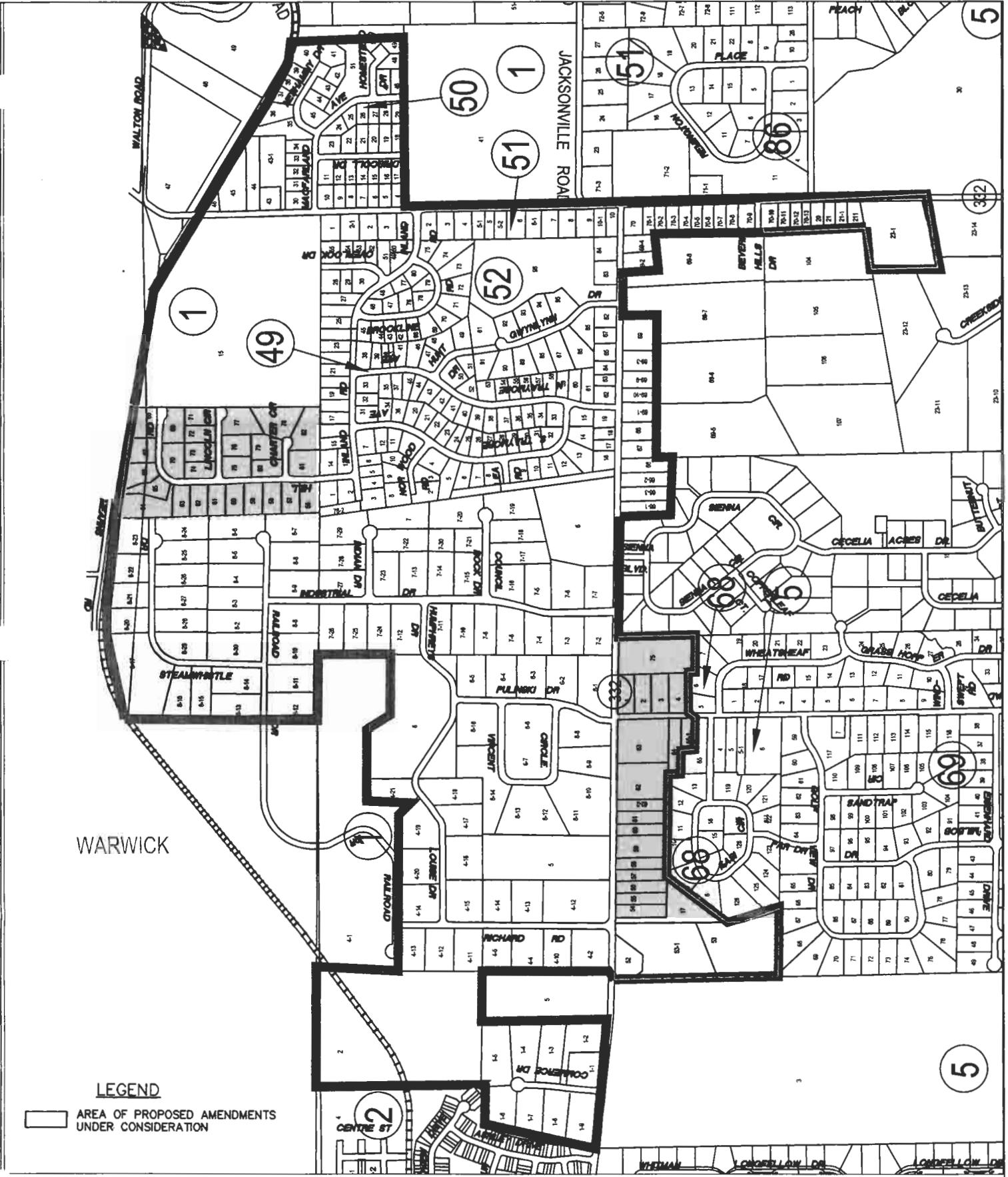
The purpose of this initiative is to explore the feasibility of reducing the scope of the project without having any negative monetary effect on participants remaining within the project. This is consistent with our goal of providing a solution to the failed systems in the region in an environmentally and economically responsible manner.

An amendment to the scope of the project would require the endorsement by several regulatory agencies and Northampton Township. The design of the project is in the very initial stages of review. Any amendments currently under consideration may be deemed not feasible or practical, based upon technical design requirements at a later date.

A copy of the proposed amendments under consideration is identified on the enclosed map. The Authority will continue to keep you informed as the project progresses.

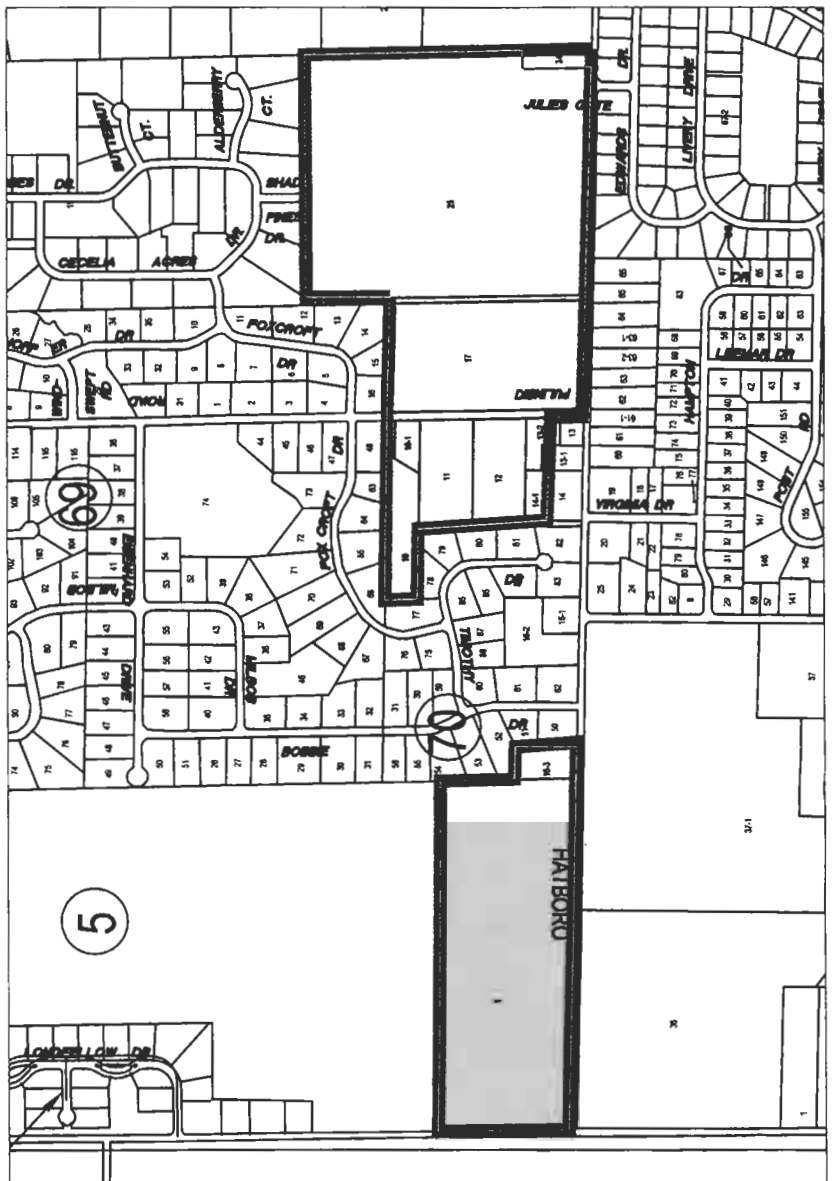
